Cardplayer Lifestyle x Women's Winter Festival Competition Terms and Conditions ("Special Terms")

The following Special Terms form the information for the Cardplayer Lifestyle x Women's Winter Festival competition ("**Competition**")

- 1. - 2. By entering the Competition, participants ("Entrants"): (a) agree to be bound by these Special Terms and the general terms and conditions for promotions located at www.pokerstars.com/poker/promotions/terms (\"General Terms") that apply to all promotions and competitions organised by the Promoter in connection with the PokerStars website located at www.pokerstars.com ("Site"); and (b) confirm that they meet all eligibility requirements for the Competition.
- 3. In these Special Terms, a reference to "you", "your", "entrant" is a reference to the persons wishing to participate in the Competition and a reference to "winner" is a reference to the winner of the Competition.
- 4. The Competition is not in conjunction with or tied to any other competition or promotions that may be running at the same time or other times.
- 5. There is no entry fee and no purchase is necessary to enter the Competition.

Who is eligible?

- 7. Entrants must meet the eligibility requirements as specified in these Special Terms and the General Terms. Failure to meet the eligibility requirements may result in an entry being invalid and/or forfeiture of any prize.
- 8. Entrants must be at least 18 years of age and not be a resident of Russia or China.
